PH 039 PUBLIC PARTICIPATION

Fourteen (14) residents of Henchard Crescent SN25 1BD attended the meeting to discuss their serious concerns regarding planning application S/LDP/24/0729. The local development plan for 6 Henchard Crescent has been noted. However, there is already a care home operating at 22 Henchard Crescent which has caused and continues to have a negative effect on the residents for a variety of reasons, including noise disruption, police presence and severe parking issues. The plans for 6 Henchard Crescent show the exact same alterations as number 22. However, this property is substantially smaller which leads to worrying concerns about parking and residents' access to their own driveway. All residents have grave concerns over a second 'care home' even suggesting it could affect or devalue their properties.
