Dear Rabyah,

As per your recent freedom of information request. I can confirm I have now looked in to your enquiries to be able to provide a response.

1. How many British Muslim employees have you recruited? Please provide figures for every year since 2010.

The Parish Council does not ask its staff for ethnicity or religion upon recruitment and therefore it is impossible to confirm the amount of British Muslims that have been appointed. It is possible that two of the employees during this time were British Muslims but have since left in 2015 and 2017, therefore, I would not be in a position to contact them retrospectively to ask. It has highlighted the importance of such questions early on in the induction stage so the Parish Council will amend its new starter forms upon recruitment to ensure that it is capturing this information promptly for future recruits.
