Minutes of the Parks & Open Spaces Committee meeting of Haydon Wick Parish Council held on Tuesday 21st February 2023.

POS 205 DECLARATIONS OF INTEREST

POS 206 PUBLIC PARTICIPATION

There was one (1) member of public present who raised the following questions:

- 1) When will the edges, mainly small trees that overgrow the main footpath (Pond Street) from Seven Fields to Blunsdon Road) hedges at Seven Fields be cut by flail?** *The hire of the mechanical flail was only for a period of 7-10 days and Seven Fields / Pond Street was not part of the scheme of works. The plan is that the edges of Seven Fields / Pond Street footpath will be cut by hand by the internal Parks & Open Spaces Team as part of the enhanced autumn/winter shrub and hedge maintenance.*
- 2) Is hand cutting efficient maintenance?** *The Head of Parks & Open Spaces confirmed that doing the works by hand will allow for a harsher cut back and will assist in future maintenance of the hedges.*
- 3) Requested some resurfacing around the car park at Mouldon Hill?** *The meeting heard that this is being programmed into Swindon Borough Council's work programme and being funded from S106 funds.*
- 4) Thanked the Parks & Open Spaces Team for the installing the bin in Mazurek Way, the residents have been very positive about it.**

Members noted the report regarding the current hedge cutting schedule and progress to date. The team is working in Haydon Wick, Greenmeadow and Moredon. The quality of the shrub maintenance has received excellent feedback and the Officers will share progress pictures on social media. Members requested a timeline for the next report to assist with managing enquiries.

PARKS & PROJECTS REPORT

Members noted the report and the work schedule of the Parks & Projects Team. Members asked when the fencing work at Basil Close will be completed, and the Head of Parks & Open Spaces updated that quotations for timber fencing are still being sought but should be received within the next couple of days and the project will be completed before the end of March 2023.

Members received recommendations from the Community Development Committee of suitable locations for the Yoga in the Park project that the Council hopes to implement in the spring/summer months. Members noted the importance of advertising people walk to these events or signposting to suitable nearby parking locations. The events will be spread across different parts of the parish to make them local for all residents to enjoy.

POS 216

MAZUREK WAY PLAY AREA MEMORIAL

Following a recent incident, the shrubs at Mazurek Way Play Area were reduced to ground level by Wiltshire Police Constabulary. The shrub beds were cut to ground level to have extensive reduction in the authority's search for potential evidence pertaining to the incident. Members considered ways in which to reinstate the hedges and received an update that the victim's family have already progressed with a memorial in Penhill. Ideas for sensory planting could be done at Ventnor Close within the Youth & Community Plot, the Head of Parks & Open Spaces will progress with this and report back.

RESOLVED: To create sensory planting areas on the Youth & Community Plot at Ventnor Close Allotments.

POS 217

TADPOLE FIELD

Members received a report regarding repairs to fencing at Tadpole Field. Members acknowledged the gaps are not that large and there are no desire lines indicating frequent public use. Future for Tadpole Field, such as creating leisure gardens, may result in a pedestrian gate and vehicle gate being installed. Members agreed to leave the field as it is, with regular monitoring and not promote public access.

PARKS & OPEN SPACES GROUNDS MAINTENANCE FACILITY

Members received a verbal update from the Grounds Maintenance Facility Working Party that final quotes have been received which has allowed the Council to budget for the expected expenditure in forthcoming financial years. The build is expected to take six months, from the date of awarding the contract. A full report will go to Full Council at the end of February 2023.

PARKS & OPEN SPACES GROUNDS MAINTENANCE FACILITY (GMF)

Members discussed the quotation received for the proposed GMF and associated costs. Some members were concerned how this could impact on the parish precept for future years, whilst other members acknowledged how far the project has come and the costs/time spent to date on the project and reiterated why Facility was needed to operate professionally and sustainably

for years to come. Some Councillors felt the recommendations needed further clarification for an informed decision eg. external project manager cost, confirmation of interest rates, a recalculation of a longer repayment term on the loan, confirmation of the life span of the building (currently 30+ years) and if there will be running cost savings once the new building is operational. Other Councillors felt that recommendations in the report should be voted on which subsequently fell. Members acknowledged that the decision was significant to the future of the Council and therefore must be discussed in depth with Full Council at the end of the month. It was noted a full report would be circulated well in advance.

Members received a report detailing outstanding tree maintenance works and costs. The work needs to be completed prior to birds nesting season which takes place in April – September. Swindon Borough Council has responsibility for some of the tree works and the Ward Councillors present confirmed they would take this on and try to find a resolution. The Head of Parks & Open Spaces will send a descriptive list through with any background information for the Ward Councillors to progress with and report back to a future meeting.
