During the financial year ended 31 March 2025, this authority's internal auditor acting independently and on the basis of an assessment of risk, carried out a selective assessment of compliance with the relevant procedures and controls in operation and obtained appropriate evidence from the authority.

The internal audit for 2024/25 has been carried out in accordance with this authority's needs and planned coverage. On the basis of the findings in the areas examined, the internal audit conclusions are summarised in this table. Internal Auditor note on test C:

The Council is required to carry out a risk assessment annually (Accounts and Audit Regulations 2015). The regulations require that the council meeting as a whole has to review their system of internal control including risk management (s.3c and s.6), although it permits the Council to consider the findings of a review carried out by a committee (s.6).

I checked to see that the minutes record the Council carrying out an annual risk assessment in the financial year. I found that the 23/24 assessment was carried out at the Council meeting on 12/12/23, but that the 24/25 review was not carried out until 22/04/25. This means that no review happened during the 24/25 financial year. As a result, I have responded 'no' to this test.
