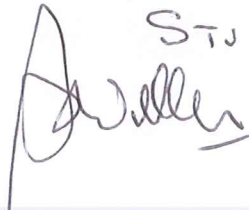

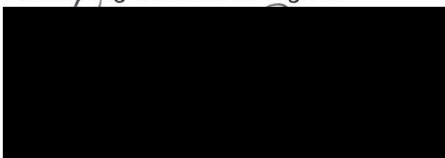

1 Respective responsibilities of the body and the auditor

Our work **does not** constitute an audit carried out in accordance with International Standards on Auditing (UK & Ireland) and **does not** provide the same level of assurance that such an audit would do.

2 External auditor report 2017/18

Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

The AGAR was not accurately completed before submission for review. The responses given in Section 1, Box 9 and Section 2, Box 11 are not consistent.

Other matters not affecting our opinion which we draw to the attention of the authority:

The smaller authority has not provided: year end bank statements to support the bank reconciliation to Section 2, Box 8. These were requested as part of our intermediate review procedures.
